

PAIR OF PROJECTS PROMOTE EFFICIENCY

Brush Creek Facility Work Moves Forward

Planned improvements at the Brush Creek Water Pollution Control Facility are progressing.

The Board of Supervisors recently authorized the bidding process for the Plant's solids handling project, upgrading the nutrient removal treatment process and improving efficiency. It's the next step in a series of upgrades to the facility over the last seven years. The bid seeks general construction, plumbing, HVAC, and electrical contractors.

The project will cost an estimated \$35 million, with \$5 million coming from a federal EPA grant and another \$1.75 million from the Pa. H2O Program. Marshall Township, which is partially served by the facility, will also contribute a significant portion via an inter-municipal agreement, with the remaining covered by a low-interest loan.

The Board also authorized Dinsmore & Shohl LLP to counsel the Township on issues related to the PennVest funding on the project.



Flowing Forward at Franklin Acres Pump Station

A project to replace one of the Township's oldest pump stations now has contractors.

The Board of Supervisors approved several contracts to replace the Franklin Acres pump station and install a new force main. The existing pump station and force main were constructed in the late 1970s and are reaching their working life expectancy. The new infrastructure will handle the current sanitary flows and the anticipated future growth in the area.

Contracts include:

- General Contractor: Wagner Development Co. Inc.
- Electrical Contractor: McCurley Houston Electric Inc.
- Force Main: E2 Landscape & Construction
- Construction Services: HRG

The project received a \$960,000 federal grant, with more funding mechanisms involved for the overall project cost.

Seasonal Workers Sought

The Township is actively hiring short- and long-season employees to help keep Cranberry looking beautiful. Seasonal employees join year-round staff to care for the Municipal Center, Fire Stations, Public Works Operations Center, neighborhood play lots, open green space, traffic islands, and building areas – as well as the Township's pristine parks.
