## Wastewater Discharge Permit FATS, OIL & GREASE

**Permittee:** RUBY'S ICE CREAM PARLOR

**Permit No:** 496

In accordance with all of the terms and conditions of Cranberry Township Ordinance No. 2006-373 (hereinafter designated "the Ordinance"), and any applicable provisions of Federal or State law and regulations, and the conditions of this permit;

For the discharge of wastewater from a food service facility or auto repair/maintenance/car wash facility into the sewage system of Cranberry Township.

### CONDITIONS OF PERMIT:

1. Permittee shall comply and shall be subject to all requirements, prohibitions, restrictions, and enforcement provisions contained in the Ordinance.
2. Permittee shall ensure through proper operation and maintenance of its grease removal device and/or through the use of best management practices that its discharge shall comply with the Ordinance.
3. Township personnel may enter the premises for the purpose of (a) inspecting Permittee's grease removal device and other facilities or processes which could adversely affect the Township's sanitary sewer system, (b) obtaining samples in order to monitor Permittee's compliance with the provisions of the Ordinance, and (c) reviewing testing records and reviewing logs and/or manifests for cleaning and hauling activities.
4. The Township may require the following, when deemed necessary by the Township for the protection of its sanitary sewer system, at Permittee's expense:
  - Additional compliance monitoring of Permittee's effluent;
  - The installation of additional pretreatment facilities to meet the provisions of the Ordinance;
  - Additional cleaning and/or pumping of Permittee's grease removal device, and/or;
  - Any other action allowed by applicable law or regulation.
5. The permit fee shall be based on the Township's current fee resolution.
6. This permit is nontransferable without prior written notice to the Township in accordance with Section 5.4 of the Ordinance.

In accordance with Section 5.6 of the Ordinance, an application for reissuance of this PERMIT must be filed at least forty five (45) days prior to the expiration date.
